



English Requirement

1. Countries exempt from taking an English exam

Your English Proficiency Exam may be waived, if you are a citizen of the following countries:

American Samoa	Dominica	Liberia
Australia	Grenada	New Zealand
Bahamas	Grand Cayman	Puerto Rico PR
Barbados	Guyana	Trinidad/Tobago
Belize	Ireland	United Kingdom

2. International applicants CAN meet CiAM’s English requirement by demonstrating one of the following:

- a) Valid English language tests and required scores*:

*Your English score cannot be older than 2 years at the time that you submit it to CIAM.

- b) Attended a U.S. educational institution for 1 year or more and earned a Degree with a 2.0 GPA or higher.
- c) Attended an institution in a country where the native language is English for 1 years or more and earned a Degree with a 2.0 GPA or higher.



- d) Attended an institution for a year or more and earned a degree with a 2.0 GPA or higher where the official language of the institution was English for ALL coursework.
- e) Attended and successfully completed a CIAM approved Intensive English program in the U.S. Please contact Office of Admissions for an approved list of English programs.
- f) Have taken a different English proficiency exam and achieved an equivalent score meets CiAM’s requirement. Please send your valid English score to Office of Admissions.

If NONE of above applies to you, you MUST complete the “English Language Exam Waiver Request” form and upload it to your [online MBA application](https://www.ciam.edu/apply-now) (<https://www.ciam.edu/apply-now>) International applicants are required to submit ALL supporting documents for the English waiver request (i.e. a degree official transcript, a professional certificate in the U.S., or a proof of completion in the CIAM approved English program, proof of working experience in an English environment **or a letter** to explain why your English score requirement should be waived etc.) All international applicants MUST complete [online MBA application](#) and pass the admissions interview and writing test (Admissions essay). The Office of Admissions will not approve or deny this request until all necessary documents have been received. You will be notified by the Office of Admissions on the result of your request.
